APPLICATION FEE:

There is a R250 per child application fee payable upon submission of the application form.

CAPITAL DEVELOPMENT ENROLMENT FEE:

A non-refundable Capital Development Enrolment Fee of R9 000 is payable per student upon acceptance into the School.

It is important to note that our school fees include ALL compulsory activities and outings, as well as the IEB Matriculation Examination Fee.
